

Easton Royal PCC

"100 Club" Rules

- 1. The Easton Royal PCC (the "PCC") will operate a Small Society Lottery as defined by the Gambling Act 2005, to be called "The Easton Royal PCC 100 Club" and hereinafter referred to as the "100 Club".
- 2. The PCC will appoint an Organizing Committee of at least 3 people to run the 100 Club. At least 2 of the Organizing Committee will be members of the PCC. The Organizing Committee will meet annually and furnish minutes of the meeting to the PCC. The PCC may remove any member of the Organizing Committee at any time.
- 3. Unless the PCC decide otherwise, the 100 Club will be activated by the Organizing Committee 0each year in time to collect subscriptions for the Club year commencing on 1st December.
- 4. The 100 Club will be open to Easton Royal residents, their families and friends.
- 5. Participants will join for a Club year starting on 1st December with the December draw being the first draw.
- 6. Each Participant will purchase one or more exclusive Numbers. Each Number to be entered into the draw may be purchased for £2 per Number per month.
- 7. Tickets will be issued to participants to notify them of their Number(s) as soon as practicable after receipt of the application form.
- 8. Participants must be 16 or over.
- 9. Payments may be made either (a) by annual cheque or cash or (b) by monthly standing order.
- 10. 50% of the net income in any 12 month period, after any expenses, will be paid out as prizes.
- 11. The amounts of prizes shall be posted on the village website by the Organizing Committee who will make the arrangements for each draw.
- 12. Prizes will be as follows:
 - 1. First prize : 30% of net income for the month
 - 2. Second prize: 10% of net income for the month
 - 3. 3rd prize: 5% of net income for the month
 - 4. In addition, a Christmas prize will be paid out at the November draw amounting to 5% of net income received that month and over the preceeding 11 months.
- 13. All undistributed net income of the 100 Club will be paid to the Easton Royal PCC for the benefit of the Church Restoration Fund.
- 14. Draws will take place 12 times a year near the end of each month. Draws will be presided over by a member of the Organising Committee or, if not available, by a member of the PCC.
- 15. The time and place of each month's draw will be posted in advance on the village website.
- 16. Except with the agreement of the Organising Committee, applications received after 10th December will not be valid.
- 17. Prizewinnings will be paid out at the draw or within one week. Prizes may be paid out in cash or by cheque in person, or by cheque to the address on participants' application forms. Winning numbers will be posted on the village website.
- 18. The PCC reserves the right to alter the Rules of the 100 Club as necessary. Participants will be notified of changes by notice on the Easton Royal website. In no circumstances will changes retrospectively disadvantage any participants. The current up-to-date Rules will be shown on the Easton Royal website
- 19. The PCC may wind up the 100 Club at any time, in which event the PCC will repay participants' payments made in advance.
- 20. In the event of a dispute the decision of the Organising Committee is final.
- 21. Unclaimed prizes will no longer be claimable after 6 months but will be treated as undistributed net income.
- 22. Participants who withdraw from the 100 Club will be entitled to a refund of any monthly payments made in advance.
- 23. The 100 Club will prepare accounts to 31 December each year for review by the PCC
