6. DAMAGE TO FOOTPATH ER22 FOLLOWING THE "ROUGH AND TUMBLE" EVENT

The bridleway track ER22 (Bruces Arms to Milton Hill) was used for the Rough and Tumble running race, based around Milton Lilbourne. It was run in early January with around 600 runners. After the race, the already muddy and fragile surface was turned into a quagmire, with a third of the track being deep, slippery mud underfoot; as a result, it is almost impassable in places and is no longer a pleasure to walk.

Beverley Helps has contacted the Rough and Tumble race organiser, Stephen Goulding, Milton Lilbourne Rights of Way officer David Hall, Milton Lilbourne PC, plus the Wiltshire Council Rights of Way people. A meeting has been arranged to meet Stephen and David to see what can be done to jointly repair and improve the track so that it can continue to be used by these events.

Beverley Helps has also contacted Pewsey Vale Running Club in the hope of discouraging them from using this now badly damaged track for their Terminator Race, which is due to be run on 23rd February. The Parish Council supports the efforts to repair and protect these footpaths.

Following the last Parish Council meeting a quote to dig out and clear the drains at the bottom of the village had been received from Brennans. The cost would be £560. Whilst it is acknowledged that in previous years Wiltshire

Council had undertaken this work, the Parish Council agreed to this payment on the basis it will clear flooding at the bottom of the village for some 3 years. It was agreed that once completed that the Parish Steward would need to maintain these ditches to keep them clear.

11. ANY OTHER BUSINESS

Following the recent review of the use of the Recreation Ground it was noted that any extension to the Village Hall or replacement would more than likely encroach onto the Recreation Ground land. Before considering any proposals for the Village Hall it was agreed to review the Recreation Ground deeds to see whether this is possible or whether specific legal advice would be required.
